From any computer or device with internet access:

- 1. Click the link on the home page of the virtual website.
- 2. Once on the ASPAN website log in with your ASPAN username and password.
- 3. Click on Events and the ASPAN National Conference Evaluations.
- 4. Click on the Evaluation Link to begin.
- 5. Once you are in the evaluation system, you will see instructions on how to navigate.
- 6. Your evaluation of a session and or poster will automatically add your contact hours to the Certificate of Attendance.

Mac Users - Be sure your computer/device is updated to the latest version of macOS. For more information on how to update your macOS, please visit: https://support.apple.com.

All Users - Be sure you are using one of the following internet browsers: Google Chrome, Firefox or Microsoft Edge. Do not use Internet Explorer, as it is no longer supported.

- Go to https://learn.aspan.org and login. You can also access ASPAN Learn by going to https://www.aspan.org, logging in, and clicking on ASPAN Learn from your My Profile page.
- Click on MY DASHBOARD (in the blue box to the left) > the title of the program > the CONTENTS tab to access the component for the on-demand module. Once you click on the title of the program, the CONTENTS tab my automatically be open.
- If you do not see the title for what you need to view/complete, check the *Filter by status* at the top of the MY DASHBOARD page. This can be changed to IN PROGRESS, ANY or COMPLETED. Select ANY to see all titles that are available to you.
